### *National Certification and Registration Program for Certified Pool-Spa Operator*

#### **NSPF EXAMINATION:**

A score of 75% or better and attendance both days of class qualifies you as a Certified Pool/Spa Operator.

#### **CPO CERTIFICATES:**

After successful completion of the course, graduates will receive a certificate suitable for framing and a CPO wallet card. Both items include your personal CPO registration number, which is permanently recorded by the National Swimming Pool Foundation. It states that the diploma was earned through the NSPF.

#### **THE TEXTBOOK:**

The textbook for the course is the Pool/Spa Operators handbook, an invaluable resource and reference for the novice and the professional who must trouble shoot on a broad spectrum of functional problems. In short, every pool operator should have one.

Subject matter includes chemistry, filtration, recirculation, all types of pool equipment, preventative maintenance, seasonal care, storage and handling of chemicals, safety, energy use and conservation and much more. All topics are written by experts with long experience in their specialties and the course has been thoroughly "field tested."
